Plan Well, Do Well

(Part 1 – Plan Well)

At the recent economic summit I was invited along with the other area mayors to provide an update on our progress relative to the “Vision Dixie” plan. For those who aren't aware Vision Dixie was a planning process that began five years ago involving hundreds of people throughout the county who met together in various locations working over table sized maps to create their visions of Washington County in the future. Puzzle pieces representing residential and commercial development of various types as well as municipal centers and recreation areas were placed on the map and then connected with road and trail systems. It was an interesting experience discussing various options with relative strangers all with differing points of view in an effort to find consensus.



The result after extensive analysis of the dozens of maps that were created was a single map representing the most agreed upon concepts that had been proposed. Along with the map ten Vision Dixie principles were established as guides for future regional and local planning. They included recommendations for integrating housing and businesses, improving transportation and conservation, protecting views and open space etc. I'd suggest you go to www.visiondixie.org and read about it. The mayors all reported that their communities have used these planning principles as they have written or revised their ordinances since 2007.



Similarly a decade ago Ivins residents were invited to join in a discussion of our vision for the future of our City as a basis for rewriting our General Plan. That too was an interesting process to be a part of as our ideas were written on the board and prioritized. Interestingly a common view emerged of what we eventually ought to become. That view became the current General Plan and has systematically been the basis for all of our planning, zoning ordinance and map revisions as well as other policies and regulations that have been created since then. Indeed as a Planning Commission, City Council, Mayor and Staff we look to the General Plan as a guide for all we do.

Interestingly many of the concepts put forward in the Vision Dixie plan were already in our revised General Plan. Others have been incorporated since. Planning is the essence of what governments do and good planning leads to good results. One of the fascinating things for me as Mayor has been my involvement in regional planning sitting on the governing board of the Washington County Water Conservancy District and the Community Education Channel and as a member of the Dixie Transportation Executive Committee, the County Council of Governments and most recently the Habitat Conservation Advisory Committee. In addition City Council members McDonald and Mendenhall serve on the boards of the Solid Waste and Mosquito Abatement Districts respectively.

In every case the object of our efforts is proper regional planning that will accurately guide local planning efforts. Both regional and local planning can look decades into the future to anticipate road right of ways and other eventual needs. Developers and other would be buyers should use the information provided in these plans to make decisions about property they are considering.



The primary planning body in ours and other cities is the Planning Commission. We have an outstanding one in place. They have over the last several months been grinding through needed updates and revisions to our Commercial Zoning

Ordinance. Often I have heard them make reference to the General Plan as they have discussed the ideas and suggestions before them. They also approve conditional use permits and review development applications to either approve or to make recommendations to the City Council. Theirs is an important role in the planning process.

The City Council has the ultimate decision making authority on policy matters in the City. After reviewing and discussing recommendations from the Planning Commission and Staff on all planning matters they determine the direction we will be going moving forward. Election to the City Council places a significant responsibility on the shoulders of its members. Few issues are simple to solve. Their oversight of the budget and expenditures is crucial to the financial health of our City. The language they authorize in our land use and development ordinances will determine the face of the City in the years to come. Ultimately the long term best interest of you our residents is the bull's eye on their legislative target.



In all matters of significance you our residents have the opportunity to be involved in the discussion. Through Citizens Comments important issues have been brought forward and acted upon leading to important changes in the City. Public hearings at both the Planning Commission and City Council levels are required any time an ordinance is revised or a land use change is considered. You are not only invited but encouraged to attend those meetings and state your position. I know it can be intimidating but your opinion is valued. It may not steer things as much as you'd like but then again it might. In any case you are a crucial part of the public discourse.



A couple of you attend frequently, a few more periodically and others only when a sensitive issue is before the body. In any case the best time to be involved is when the planning is being done. Your contribution of time and effort is most valuable then. Angry reactions to ordinances or regulations that have been recently passed without your input are far less effective and far more draining than providing research and opinion early in the planning process. I assure you that you will be treated with respect and listened to carefully. I believe every Planning Commission and City Council Member is genuinely interested in what you have to say and waits to make up his or her mind until you've been heard.



The agenda items for all public meetings are posted on the Ivins website and published in both the monthly newsletter and in the Spectrum. I urge you to track the issues being considered and involve yourself to the extent you can. All of our City ordinances and plans are "living documents" systematically reviewed and subject to change. Your contribution to the public process insures that our planning for the future represents your interests and that the future of the City will reflect at least in part your vision of it.

The Pet Corner

Aggie Smith, Ivins Animal Shelter

Ivins Animal Control has seen an increase in calls about dogs at large in our city. We want all our citizens to be informed as to the laws regarding this issue. Below are the city codes for animals at large. I also listed the city code for animals disturbing the neighborhood.

The Ivins City Code 6.05.102: "It shall be unlawful for the owner or custodian of any animal to allow such animals to run at large. The owner or person charged with responsibility for an animal found running at large shall be strictly liable for a violation of this section regardless of the precautions taken to prevent the escape of the animal and regardless of whether or not he knows that the animal is running at large." This ordinance applies to cats as they are considered animals also.



The Ivins City Code 6.05.111: Dogs and cats disturbing neighborhood: "It shall be unlawful for any person to keep or harbor any dog or cat which by loud, continued or frequent barking, howling, yelping meowing, screeching or noxious or offensive odors shall annoy, disturb or endanger the health and welfare of any person or neighborhood. This section shall not apply to city animal shelter or veterinary hospital."

Dogs running at large cause so many problems for neighborhoods. At large dogs are a danger to cars and children, plus they may defecate on the property of others. This is not acceptable for the health and well-being of the neighborhood or of the dogs and cats.

The first thing animal control would like to see in any of these cases is civil communication between neighbors. So many times owners are just not aware of their dog's barking. However, if this does not resolve the issue please call animal control. Upon the first report to us we issue a warning, the second report however does carry a penalty of a citation for violation of city ordinance.

Animal control would be happy to answer any other questions you might have regarding these issues. We all want to keep Ivins a safe and enjoyable community for animals and people alike. Please contact us at 435-628-1049.

Community Garden

The Ivins Community Garden is located at approximately 900 S. on 200 E. The garden plots range in size from 8' x 20' (160 Sq. Ft) to 20' x 20' (400 Sq. Ft.). We are planning to use irrigation water again but it will not be available until April, so if you plant before then, you will have to carry your own water.

Ivins City will administer the Community Garden and require registration and compliance with Community Garden Guidelines. Gardeners must register with Ivins City prior to working in the Community Garden. All garden plots are assigned on a

first come, first served basis. A waiting list will be kept for future garden plot availability.

An annual refundable deposit of \$30 and an annual non-refundable deposit of \$20 are required at registration. The annual refundable deposit of \$30 will be returned (or held for the next year) if the garden plot is cleared by October 31. The annual non-refundable deposit of \$20 will be used to cover costs of plot preparation, irrigation material and mulch. The refundable deposit may be returned or rolled over for a garden plot for the next year. Deposits may be made with cash, check, or credit card. If a garden plot over-waters, has weeds, or is not in compliance with these guidelines, the refundable deposit will be forfeited and the gardener's right to use of the garden plot will be revoked. We will have approximately 10 tons mulch available in March, but that is all we will provide.

We will begin taking reservations on February 13, 2012.
