

RESOLUTION NO. 2019-11R

**A Resolution of Ivins City, Utah,
Amending The Consolidated Fee Schedule**

WHEREAS, the City Council desires to amend the City's Consolidated Fee Schedule.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF IVINS CITY, STATE OF UTAH, AS FOLLOWS:

SECTION 1. The Consolidated Fee Schedule shall be amended as set forth on Exhibit "A" attached hereto.

Effective Date: With the exception of Culinary and Irrigation Water Impact Fees, this Resolution shall become effective July 1, 2019. Culinary and Irrigation Water Impact Fees were approved and adopted by Ordinance No. 2019-02 on February 7, 2019 and effective 90 days after approval.

PASSED AND ADOPTED BY THE IVINS CITY COUNCIL, STATE OF UTAH, ON THE 16th DAY OF MAY, 2019. ALL COUNCIL MEMBERS PRESENT VOTED IN FAVOR. ONE COUNCIL MEMBER WAS ABSENT.
