# THINK INSIDE THE BOX ARTICLE BY: CHRIS HART, MAYOR

April 20th is the date for Utah's annual "Great Shake Out" emergency exercise that mobilizes County Emergency Management personnel and local first responders statewide. In conjunction with that exercise, as we have done in the past, the Ivins Emergency Preparedness Committee under the direction of SCI Fire and Rescue will conduct our annual "Go to the Box" disaster drill. At 6:00 p.m. the emergency siren located atop of the Center Street Fire Station will sound at which time you are requested to go immediately to the nearest Disaster Hub Box, generally located on a nearby street sign post, open it and follow the written instructions inside. For those out of hearing range of the siren please watch your clocks and do the same thing at the appointed time.



Building on previous drills, it is our intent this year to have you conduct mock neighborhood damage assessments and report your findings using the Hub Boxes built in radio communication system to test the effectiveness of our communication network and our ability to convey critical information to our Emergency Operations Center (EOC). Our entire Disaster Response Plan is based on your ability to get to a Hub Box, open it and follow the instructions printed on the clipboards inside. In an actual critical emergency, you, our residents will become the on scene eyes and ears for our professional first responders as you en masse determine where the critical needs are, report them by radio and receive follow up instructions as to where your help is most needed. All of these functions are conducted through the Disaster Hub Boxes.

With greater numbers of you becoming CERT trained we will increasingly rely on you to act as coordinators overseeing neighborhood damage assessment and reporting functions as well as the follow up early relief efforts under the direction of the EOC. CERT training is an excellent tool in our city emergency kit and is available to every resident in their mid-teens and older at no charge. Much of the required training is available online supplemented by in person coaching & testing done by SCI Fire and Rescue personnel. If you desire to participate in that program please contact me at chart@ivins.com and I will arrange for your training to be scheduled.

Lastly I want to note the recent passing of Paul Wheeler, former Chair of our Emergency Preparation Committee, who contributed much of his valuable time and expertise over a period of several years to advance our capability as a community to deal with a disaster situation. Thank you, Paul.

Having successfully completed our Talkabouts on water and housing, we now have the opportunity to gain a much improved understanding of our city's finances and what will be required for them to remain stable in the future. Long term financial sustainability has become somewhat of a science and we are so fortunate to have Joe Minicozzi, the founder of Urban 3, the preeminent municipal finance analysts and planners in the U.S., joining us by Zoom for the first half of the meeting. Joe will explain to us using his remarkable 3D graphs and other data the dynamics of revenue flow in communities like ours and the planning required for a city to be remain stable long term. I think you will find his presentation captivating and he will answer your questions at the conclusion of his presentation. Ivins along with other Washington County cities are currently contemplating hiring Joe's firm, Urban 3, to create Finance Master Plans to guide us in our current and future planning.

The second half of the meeting will begin with a presentation by our Director of Finance, Cade Visser, that will focus on Ivins City's current revenue situation & trends and will conclude with a variety of future finance scenarios based on differing assumptions as to how we will continue to develop moving towards our eventual build out.

We will then consider the practical financial realities of our survey results and explore the mechanisms by which we might eventually achieve some of those goals. I personally think this will be a fascinating discussion and hope you will plan to attend. The "Talkabout on Finance" will once again be held at Rocky Vista University on Wednesday evening, April 19th, at 7:00 p.m., and like previous Talkabouts you may also attend via zoom at the following address; https://us02web.zoom.us/j/82133903373. # Ivins City History Articles by: Cherise Ence Spencer

In celebration of the 100 year settlement of Ivins, I am sharing with you some of the stories about the original pioneer families of Ivins. For the next 12 months I will be putting a spotlight on each of the families and their accomplishments. I hope you enjoy reading about them as much as I have. I want to thank Emma Fife who wrote "History of The Santa Clara Bench - Ivins Our Home Beneath the Red Mountain", Kay and Ellen Ence who wrote "Lillie and Milo Ence Pioneer Stalwarts", The Washington County Historical Society, and the website Familysearch.org where I am able to read and learn about all these wonderful pioneers. - Cherise

Milo and Lillie Ence were the eighth family to move into Ivins in the spring of 1924 with two young boys; they lived in a one room adobe house with a cellar underneath. Like all the young families that first settled Ivins, they started out with humble means but were excited to start farming and taking care of their own land. They also purchased a team of horses and a wagon for \$600, this was their means of making a living and a way to get to Santa Clara for church and recreation. Milo and his team spent many days building the canal and reservoir. He also put in so much time building the chapel and was very proud of that. Milo said "We excavated for the foundation, hauled the gravel and sand for the entire structure, helped with the laying up of the walls and what carpenter work we could do. When the building was ready to be dedicated, an inspiring meeting was held."



Farming in the Ivins sand was very hard work and this hard work was a family affair, with Lillie doing a lot of hoeing from morning until night. and the children working alongside her. The garden spot was between the house and the barn and also across the street from the house. They raised wonderful cantaloupes, tomatoes, corn and large striped watermelons. They would pick out the very best and take it to the stores in St. George to sell. A lot of their livelihood depended on what they could raise and what Milo could peddle. Afton their son wrote "We would eat what was in season. Corn for breakfast and corn for dinner. If we had beans, we had beans twice a day. Once a month, we went to St. George to the old Ice House and got 25 pounds of ice and made ice cream. We would buy a loaf of bread at the bakery. We would eat the bread with the ice cream just like it was cake."

Milo also continued to haul wood from the mountains when he had the time. This was not only for their own use, but also for sale. The red sand was really deep and got very hot in the summer and one night as Milo was returning from a wood trip, it got dark. As he neared home, the horses could not pull the load any further, so he finally unhitched them and went on home. Upon his return the next morning, he found that the road had washed out and there were holes where his horses had struggled to pull the wagon. Eventually, they were able to acquire a 1929 Chevy Coupe and made a rack for the back to do the peddling in. This was a much faster, easier way to travel.

Afton remembers, "When they were building the old highway, the men were working with their teams of horses. Pa and Reuben were using a horse drawn road grader and Ed Tobler used a horse drawn scraper." It was Milo's sons, Afton and Vendon's job to be the water boys for this project. They would walk rather than ride their horses back and forth because it was so cold. They could keep warm better walking than they could while riding a horse. Afton remembered how chapped the sides of their legs would get since the water bags were wet and would rub against the sides of their legs as they walked. He also remembered that they worked all winter on that road.

By 1931, two more boys were added to the family, Irvin and Kay. With the addition of more children it became necessary for the two older boys to sleep outside. They slept under a horse blanket and there were even times when they would wake up with snow on the blanket. Then after a while they got a "lean to" they slept under and then they slept in an old discarded bus.



Milo was the water master for many years and would check on the Winsor Dam, while doing this he became very good friends with the Shivwits Band of Paiutes especially with Tony Tillahash and Stewart Snow. The Milo Ence family has always felt that it was a special honor when Stewart Snow asked to speak at Milo's funeral to represent the Paiute Band.

Industry and thriftiness is something they grew up learning from their parents. They tried their hand at many projects, some they enjoyed and others not as much. They tried their hand at raising sugar cane and making it into molasses. They also decided to try raising turkeys for a few years. But with the coyotes, weather, and

the turkeys from one place to the next, their son Vendon said, "It always amazed him when they were out riding for the cattle, Pa could call and the cows would come right out of the trees for him." The cattle round up and drive was long and hard, but a time the boys could all enjoy together. But one of Milo's favorite jobs was being the school bus driver. He drove the school bus for 25 years and everyone loved him dearly.

Unfortunately in December 1957, Milo passed away leaving a sad family and a very sad wife. Lillie continued to live in Ivins for the remainder of her life. She was always active and would walk to the post office each day to get the mail, and she would stop in to visit with Lula or Mata or any of the other women in Ivins. Sometimes the women would go on little drives together. She also loved spending time with her family. Irvin and Kay remember Christmas at Ma and Pa's house, "As the family grew and the house didn't, we were really packed in, but that did not matter. We loved being together."

Our 4th and 5th grade students were able to participate in an art project that will be shared throughout the community. Coyote Tale's ART-O-MATIC is a repurposed gumball machine selling unique lilliputian crafts. For only fifty cents and a twirl of the knob, you can be the recipient of a capsule containing a one-of-a-kind, diminutive work of art created by a Red Mountain Elementary school student. 100% of the proceeds from the sale of the art will be donated to Red Mountain Elementary School to purchase more art supplies for the students

The project was funded by Coyote Tales Storytelling events using funds raised from a pre-covid event's gourmet bake sale concession stand. Audience members purchased upscale treats donated by Petite Feast. All proceeds from the bake sale were used to purchase the machines and art supplies to hold a special art experience for the fourth and fifth graders. During the class, the children sculpted and then painted figures inspired by their studies of the rainforest. An array of miniature frogs, toucans, flowers and snakes are enclosed within the machine's capsules. Additional capsules contain haikus written by students. The machines will be stationed at Datura Art Gallery in the Kayenta Art Village, at Red Mountain Elementary School and other Ivins locations.

# TO DUMP OR NOT TO DUMP

In the current construction environment, we are experiencing builders, homeowners, or other people dumping rocks, sand, or other construction materials on city streets. Dumping on the city street is permittable, but only if the builder or homeowner obtains an encroachment permit. There are city permits that help with requirements for traffic control and the need for insurance, as well as permits that are time specific or explain any other requirements needed. These permits can be obtained by visiting the Building Department at Ivins City Hall.

The challenge we as the police department face is when someone has materials dropped off on a city street while remodeling, repairing, or for other reasons without a permit. In this case, there will be no traffic warning device, no barricades, and this material could be left in the street for an unknown period of time. Many projects are weekend projects, where the owner or resident can only work on them when they have spare time.

We have received complaints lately from residents regarding building materials left on the road and complaints about the time it takes to complete these projects.

Our department's approach has been to contact the builder, resident or homeowner about the complaint or violation. The response is usually favorable; however, the issue comes back to homeowners and builders taking responsibility for their projects and taking the proper steps to ensure safety. We need to realize that any traffic hazard becomes more critical when visibility is limited. The possibility of pedestrian or traffic accidents increases, and the legal aspect of liability can become critical to all involved. If we, as a police department, are made aware of a problem and do not address it, we may expose lvins City as well as residents of our city to other issues. We are always willing to work with residents who are in the building process, but we cannot expose the City to unnecessary liability for failing to address a public safety issue.

If you are in the process of building, remodeling, or even yard work, speaking with the Building Department, getting a permit, and understanding the rules for those permits, will help keep us all safe.



#### Protecting our Water System from Contamination by Preventing Backflow

One of our top concerns with the operation of the Ivins City water system is the protection of the system from contamination. One of the safety measures, among many, that have been taken by the City is to install a double check valve at your water service connection to help prevent contamination from a condition called backflow.

In normal operating conditions backflow is not generally a concern, but backflow can occur when there is a shock in the distribution system, such as a water line break or the opening of a fire hydrant, that causes a sudden drop in pressure in the main pipes which will actual suck water from any open connections.



The service connection double check valve should prevent contamination of the main pipes, from the residential service, but each property owner is required to have a few additional measures to prevent cross-connections that would possibly cause a contamination within their own system.

Federal, State and Local laws are in place to establish a Cross-Connection Control program. This is necessary to keep drinking water safe. See Ivins City Code on our website (www.ivins.com) under Title 10 Chapter 4, which outlines the requirements for backflow prevention devices and disallows any cross-connections. If you are installing an irrigation system or you think that your irrigation system is not compliant, you might want to get familiar with this law, or hire a professional that is. Typically, a residential irrigation system is installed with an anti-siphon assembly that can be purchased at an irrigation supply store. Outdoor hose bibs have a vacuum breaker attachment. Also, if you have both culinary and irrigation water connected to your property, you should never have both systems connected at the same time. This would be an illegal cross-connection.

One last thing, because of the check valve installed on the service meter, all homeowners should keep this in mind when reviewing or modifying house plumbing because of something called thermal expansion. When the water heater warms up the water, the water will slightly expand and since our service connection prevents the water from expanding into the water main in the street, the expansion must go somewhere else. Typically a small thermal expansion tank is installed on exit piping of the water heater, but if you don't have that you may be relying on a relief valve installed on the water heater or in the tank of a toilet somewhere in the house.

# **CONSTRUCTION UPDATES**

Highway 91 Project: The HWY 91 project began early February. To date, they've been working on the sewer near Kwavasa Drive and on the clearing of the roadway shoulders from about 200 East to 600 West. There have been several weather delays that will likely have an impact on the final completion date of the project. Information will be provided as the project gets closer to completion.

The project generally entails resurfacing the roadway, adding a center landscape median, adding bikelanes to HWY 91 from 200 East to Kwavasa, adding an 11' wide pedestrian trail on the north side of HWY 91 from 200 East to Fire Lake Park, and the construction of two roundabouts located at 400 West and Kwavasa. There will also be some utility improvements as well as intersection improvements at 200 West and Main Street. Anticiapte mild to moderate distruption along HWY 91 continuing until September.

It is anticipated that the roadways and roundabouts will be done in segments. Below are the general segments and the anticipated work timeline:

Road Segment 1 - 200 East to 400 West – late February to late April (about 55 days)

Road Segment 2 – 400 West Roundabout – mid April to early June (about 40 days)

Road Segment 3 – 400 West to Kwavasa – early June to early July (about 30 days)

Road Segment 4 – Kwavasa Roundabout – early May to mid June (about 40 days)

A final asphalt overlay of all road segments, between 200 East and Kwavasa, is anticipated to done in July.

The trails are also anticipated to be done in segments, below are the general segments and the anticipated work timeline:

Trail Segment 1 – 200 East to Main Street – early February to early April (20 days)

Trail Segment 2 – Main Street to 400 West – late February to late April (30 days)

Trail Segment 3 – 400 West Roundabout – late February to early May (35 days)

Trail Segment 4 – 400 West to Kwavasa – late March to late May (30 days) Trail Segment 5 – Kwavasa to Kayenta Parkway – early April to late June (50 days)
